The following are some of the Rules and Ordinances of the Town of Kensington, New Hampshire:

- Grilling in Designated Area only
- Bikes and Horses Permitted on Woodland Trails Only
- Skateboards, Roller Blades and Scooters Allowed in Skateboard Park area only
- Dogs Must be Leashed at all times
- Pickup After your Dog or Horse
- No Animals on playing Fields
- Authorized Vehicles Only
- Firearms Not Allowed
- Dispose of Waste in Proper Receptacles
- Proper Conduct Required
- PERMITS REQUIRED FOR: Alcoholic Beverages, Fires, Explosives or Fireworks, Sound Amplification Equipment, Sleeping at Night, Organized Groups of 25 or More.

Parking on Trundlebed Lane is not permitted and will be controlled with the posting of temporary **No Parking Signs** prior to each event taking place. At the end of the event the responsible party will take down and store all temporary **No Parking Signs** in their designated area. A violation of this Ordinance will result in ticketing and possibly towing any vehicle(s) parked illegally. A violation of \$25 per vehicle shall be issued to the person(s) responsible for the event. **All parking must be in designated parking areas only and not on Trundlebed Lane.**

Any violation of the Alcoholic Beverage ordinance will result in a fine of \$100 being issued to the person(s) responsible for the event as well as those individuals possessing or consuming alcoholic beverages. **Consuming of Alcohol in the park or any parking lots is not permitted.**

All trash will be picked up off the ground and placed in the proper receptacles prior to leaving the park and the parking lots. Failure to do so will result in a fine of \$100 for the first offense, \$250 for the second offense and \$500 for the third offense.

I understand that I am responsible for enforcement and supervision of these rules and agree to the Terms and Conditions set forth above. I also understand that in order to assist in the policing of the policies and ordinances a request for a police detail officer(s) may be made to the Kensington Police Department at an additional cost to me. I certify that on behalf of the applicant or organization, I am also authorized to commit that organization, and thereof agree to be financially responsible for any cost and fees that may be incurred by or on behalf of the event to the Town of Kensington.
